TO : PRC OFFICERS AND EMPLOYEES OF THE CENTRAL AND REGIONAL OFFICES

SUBJECT : ASSESSMENT OF ANNUAL REGISTRATION FEES (ARF) FOR CY 2023

For uniformity and effectiveness in the delivery of public service particularly the issuance of Professional Identification Cards (PIC), all concerned are hereby enjoined to refer to the following tables herewith attached as guide and reference in the computation and assessment of annual registration fees for CY 2023.

Table 1 - For Baccalaureate Professions
Table 2 - For Non-Baccalaureate Professions

The attached tables of assessment in the renewal of annual registration fees (ARF) shall be enforced accordingly for CY 2023 subject to change or adjustment as may be prescribed or required.

Registered professionals may be allowed to renew their PIC one year prior to the actual expiry date. However, it is understood that the renewed PIC for CY 2023 shall be valid for three (3) years or until 2026 as prescribed in the table of assessment.

All Heads of concerned offices and divisions are hereby directed to monitor the proper implementation of this Memorandum.
